Notes:

- 1) The Nomination papers may be collected from the office of U.P. Athletics Association on or after 6th May 2023.
- 2) The President / Secretary U.P. Athletics Association will nominate the Returning Officer.
- 3) Nomination for any post of Executive Committee Member shall be proposed by one of the authorized representative of the Member Unit(s) whose name is included in the Electoral College list, and also subscribed by one such representative as seconder.
- 4) Each Nomination Paper shall be delivered to the Returning Officer or his nominated authorized official,
- 5) Notice of withdrawal of candidature shall be submitted either by candidate himself/herself or a person duly authorized by him/her in writing.
- 6) After submission of Notice of withdrawal of candidature, the Notice shall be final and shall not be allowed to be cancelled.
- 7) Copies of the Aadhar Card, Date of Birth Certificate, NOC (Incase of Government Employee) for the Post of President, Secretary & Treasurer is mandatory.
- 8) A poll shall be taken by Secret Ballot for those posts remaining unfilled.
- 9) The ballot papers for these posts remaining unfilled shall be made individually for each post.
- 10) The names of the contesting candidates on the ballot papers shall appear for each post, in alphabetical order according to English alphabets.
- 11) The guidelines of "Election Procedure" in the Appendix of Constitution of AFI and the Rules & Regulations mentioned in the Constitution of UPAA shall apply for the purpose of Election.
